

Relatedly, the Al boom has provided an uplift to particular states and industries.

"Al is primarily a bigger-city office technology. Most of its superstar and star hubs are in California's coastal cities, Texas' business cities and the Boston to Washington corridor," says Mark Muro, senior fellow at the Brookings Institution. "Data centre construction is also booming across the US, but this leads more to a short-term surge in building activity."

Pantheon Macroeconomics estimates that **US GDP would have grown at a mere 0.6 per cent annualised rate in the first half were it not for Al-related spending**, or half the actual rate.

Beyond the surge in Al-related spending, private investment elsewhere in the US economy has started to shrink this year under the weight of higher interest rates and uncertainty.


Total private fixed investment rose by about 3 per cent year on year in the second quarter, but it would have fallen by around 1.5 per cent if Al-related components were excluded, says Pantheon in a recent research note. The annual rate of data centre construction has grown over Trump's second term — but residential, manufacturing and other commercial building work have declined.





#### 2025 Long-Term Population Projections






# **State Population Changes Attributable to Interstate Migration (FY 2024)**

#### Affordability gap -\$66,000 \$0 \$50,000








#### YOUNG ADULTS AGES 25-34: % LIVING WITH PARENTS

# **Tariffs – Winning EDO strategies**

- Educate yourself on how foreign trade zones could blunt some of the impacts
- Facilitate finding domestic suppliers/vendors for your local businesses
- Host a seminar on navigating the tariff situation
- Increase your focus on attracting FDI
- Maximize state and other incentives for use of ports



# **Taxes**





#### **Taxes – Pro-Growth Provisions**

- Immediate expensing of capital investment, even for real property through 2029
- Increase R&D deductions
- Enhanced deductibility of corporate debt
- Maintains tax treatment of economic development incentives (Section 118)
- Opportunity Zone enhancements (with special emphasis on rural America)
- Renewable energy credits a mixed bag
  - Nuclear and geothermal safe
  - Solar, hydrogen, and wind phase out (may accelerate projects in the pipeline)



# **Taxes – Winning EDO Strategies**

- Partner with law firm/accounting firm on seminar for local businesses on OBBB implications
- Explore complementary tax policies at the state and local level
- Align site investments/marketing with OBBB priorities
- Monitor state tax conformity in 2026 state legislative sessions

- Executive Order 14278 Preparing Americans for High-Paying Skilled Trade Jobs of the Future – expand apprenticeships and streamline/align federal workforce training programs
- Executive Order 14269 Restoring America's Maritime Dominance
   invest in maritime industrial base and block Chinese shipping
- Executive Order 14255 Establishing the United States Investment Accelerator – orders federal agencies to speed permits for economic development projects valued at over \$1 billion

- Executive Order 14307 Unleashing American Drone Dominance

   promote domestic UAV and eVTOL production and reduce
   regulatory barriers
- Executive Order 14304 Leading the World in Supersonic Flight regulatory reform and increased R&D investment
- Executive Order 14302 Reinvigorating the Nuclear Industrial Base – regulatory reform, workforce investment, and accelerate plant construction
- Executive Order 14285 Unleashing America's Offshore Minerals and Resources – permit streamlining, mapping



# **Executive Orders – Winning EDO Strategies**

- Seek alignment between your target industries and EO priorities
- Work with your state EDO to get federal partners to advocate for you having a seat at the table as the EO is implemented
- Convene a local working group to provide ideas on regulatory reform, workforce training, and other suggestions to guide the EO implementation team
- Outreach to industry associations to make them aware of your interest in EO implementation

#### Infrastructure is KING

- Companies want to move quickly and don't have time to wait for utilities, roads, power to be delivered to sites
- Economic growth of the past 5 years, particularly e-commerce, renewables, and data centers, have strained the ability of communities and private developers to keep up with delivering new sites
- Infrastructure construction costs continue to rise faster than inflation
- Supply chain constraints continue to plague new development
- Construction labor is constrained because of immigration policy



# Infrastructure – Winning EDO Strategies

- Identify future utility corridors and secure ROW now
- Federal grants STILL exist, so develop and implement a pursuit strategy
- Facilitate workforce partnerships to grow construction labor force
- Look for opportunities to streamline permitting processes
- Assess stranded infrastructure assets at closed facilities for repurposing
