

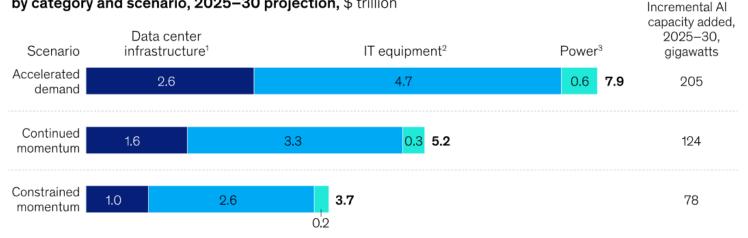






#### Capital investments to support Al-related data center capacity demand could range from about \$3 trillion to \$8 trillion by 2030.







- Executive Order 14302 Reinvigorating the Nuclear Industrial Base regulatory reform, workforce investment, and accelerate plant construction










#### **Winning Strategies**

- Clearly identify the threats caused by congestion and the opportunities created by solving it
- Embrace "all of the above" strategies for solving congestion challenges
- Ensure that solutions are hyper-local
- Successful regional strategies have both road and transit solutions
- Cobble together various funding streams instead of looking for a silver bullet



# TAKE THE GUESSWORK OUT OF SOLUTIONS



#### **Winning Strategies**

- Political polling and surveys to test voter attitudes and seek winning messages around solutions
- Continuously seek public input and feedback on proposed projects
- Convene an employer panel to look for creative solutions to congestion (more ride sharing, staggered hours, subsidies, alignment of hybrid work schedules)

#### **Winning Strategies**

- Commitment by public bodies to full transparency on how project decisions are made
- Create an "accountability" commission with oversight of projects
- Any funding programs must be linked to specific projects, not a generic platform to "reduce congestion" or "expand roads"
- Create a scoring rubric to rank projects using objective criteria
- Be willing to admit mistakes and move on



# FUNDING AND PROCUREMENT IDEAS





#### **Winning Strategies**

- Increase density around transit nodes
- Explore public-private partnerships that appropriately share project risk
- Enact tax increment financing/overlay structures to capture value created by new transportation nodes
